INTERMEDIATE VIBRATION ANALYSIS & ISO CAT-2 CERTIFICATION

DESCRIPTION:

This 4-day course complies with ISO standard 18436-2. Category II vibration analysts are expected to be able to select appropriate vibration measurement techniques, set up instruments for basic resolution of amplitude, frequency, and time, perform basic spectrum analysis, maintain a database of results and trends, perform single-channel impact tests, classify, interpret, and evaluate test results in accordance with applicable specifications and standards, recommend minor corrective actions, and understand basic single plane field balancing concepts. Discussions of case histories on machinery faults are one of the focal points of this course.
