While the first five are for projects that have come up anywhere in India during the past 3 years (Commissioned after 1st June 2015), the last category is for Refrigeration products either manufactured in India or imported into India and are commercially available for use in the country.

The Award will be bestowed upon the Project / Product that has demonstrated excellence by focusing on innovation, energy efficiency and concern for the environment and in the process showcase a project or a product which others can look up to. The winners of the REFCOLD INDIA EMERSON Awards would have demonstrated excellence in the project or product design space by delivering high performance.

Each category will have a winner and a runner-up. These will be selected by an eminent panel of independent jury members.

There is a simple nomination form to be filled in (Copy Attached as Annexure - A). From the nominations received upto 31st July 2018, the Award recipient will be adjudged on the basis of several parameters, which will involve in-depth primary interviews conducted by the ISHRAE refrigeration committee. It will shortlist eligible nominations for which more intensive data will be collected and these will be presented to the jury for selecting the Winner & Runner-up.

In respect of projects, owner's consent to participate in the competition is essential. The owner should be willing to share data sought by the committee/jury and should also agree to a possible visit by jury to the installation.

Awards will be presented at a grand function on the first day of the exhibition (22nd Nov 2018) to honor the winners.

In all matters relating to the award, the decision of ISHRAE Refrigeration committee and/or Jury will be final and binding.

1. Nomination can be sent by anyone who is familiar with the Project/Product being nominated.
2. The Project should be operational as on 31/07/18 and the nominated Product should be commercially available in India as on 31/07/18.
3. All categories will have a winner and a runner-up award.
4. All nominations received before 31/07/2018 will be reviewed by a Screening Committee. Shortlisted nominations will be required to submit a detailed application form for scrutiny by the REFCOLD INDIA EMERSON Award Jury.
5. Decision of Jury will be final and binding.
6. Selected awardees will be invited to visit REFCOLD INDIA which is being held at Gandhinagar (Mahatma Mandir Convention Centre) on 22/11/18 and receive the award in person.
7. Any Project or Product connected with the Screening Committee / Jury will not be eligible to be considered.
8. Screening Committee / Jury may ask for relevant data and may also visit the installation. Any Project where owner refuses to share data or does not allow access for inspection will automatically be disqualified.
